**Secretary's Report** – Tim Koch

Board members had previously reviewed and approved the minutes of the January 4, 2010 meeting, with copies posted on the website and the league bulletin board.

Membership dues for 2010 are already reaching budgeted amounts.

Sponsor fees have been coming in; some yet to arrive.

Dick will adjust budget for range ball expenses and M/G expenses.

Dick will meet with Larry Zelikoff and Dan Hoshino to resolve M/G and report in March.

**Marketing Chairman's Report** – Carl Hunt

Carl provided handouts for the Hole-in-One program sponsors and our 2010 Business Sponsors. We have a new business card holder in the league room; for our sponsors. Carl is looking into a new idea for tee-box signage to give sponsors more exposure.

Jon M. reiterated that Carl needs help with this committee.

**Tournament Chairman's Report** – Mick Borm (absent)

Jon M. reported that the format for 2/6 league play has been modified due to full field, pace of play and luncheon concerns.

**Rules Chairman** – Phil Gray

Phil has been receiving email questions about rules from members; will review proper placement or replaying a ball crossing a hazard line at the luncheon.

We will continue to stress the 14-club limit rule; some players misunderstand the standing of a "rock club" as an official club in one's bag. For play beginning on 2/17 we will institute a program of players checking the number of clubs in the bags in the other cart on the first hole to be played. Any clubs over 14 must be removed and placed in the "other" cart for the duration of the round. [This process is a compromise from having to return to the parking lot.]

Phil also discussed Sky Caddies, and emphasized the need to "play by the rules" in all rounds, not just on Wed's. To do otherwise can affect handicaps, and is not in the spirit of the game.

**Handicap Chairman** – Jon Grantham

Our league plaques are from league sponsor Creative Awards. The entire H-cap Committee is participating in recertification on 2/9/2010.

**Special Events Chairman** – Larry Zelikoff
